



Contributions to a Candidate at an Election Information Return

- This return must be completed by each official agent of an officially nominated candidate at an election of a member or members to serve in the House of Commons of Canada, unless the appointment of the agent had been terminated before completion of the duties in respect of that particular election. For help completing this return, see the **Income Tax Information Circular 75-2R9**.
- Mail the completed return and any attachments to: **Charities Directorate, Canada Revenue Agency, Ottawa ON K1A 0L5**, within four months after polling day, or, if applicable, within four months of the date of publication in the Canada Gazette of the notice of withdrawal or deemed withdrawal of the writ issued for the electoral district for which the candidate was nominated.
- If you are the official agent or a predecessor official agent, you must keep a copy of each receipt that you signed for income tax purposes. The receipts are for monetary contributions to the candidate during the period covered by this return. You must keep the receipts for two years after the end of the last calendar year in which the donations were made, and you must make them available to the Canada Revenue Agency during that time.
