



# Provincial Tuition and Education Amounts

Complete this schedule using your completed Form T2202, TL11A, TL11C, or other official tuition tax receipts. For more information, see Guide P105, Students and Income Tax.

**Note:** Only the student completes this schedule and attaches it to their return. The person claiming the transferred amount does **not** attach this schedule to their return.

## Prince Edward Island tuition and education amounts claimed for 2019

Enter your unused Prince Edward Island tuition and education amounts from your 2018 notice of assessment or reassessment. (If you resided in another province or territory on December 31, 2018, you must determine which amount from your 2018 notice of assessment or reassessment to enter. If you resided in Quebec on December 31, 2018, use the federal tuition, education, and textbook amount. If not, use the **least** of the provincial, territorial, and federal amounts.)

Enter your eligible tuition fees paid for 2019. **59140** 2

### Education amount for 2019

Use the information on Forms T2202, TL11A, and TL11C to complete lines 3 and 4.

Only one claim per month (**maximum 12 months**).

If you ticked box 32005 of your federal Schedule 11, do **not** complete line 3. Instead, complete line 4 using the number of months you entered in box 32010 of your federal Schedule 11.

Enter the number of months from box 24 of Form T2202 and column B of Forms TL11A and TL11C.  $\times \$120 = \mathbf{59160} +$  3

Enter the number of months from box 25 of Form T2202 and column C of Forms TL11A and TL11C.  $\times \$400 = \mathbf{59180} +$  4

Add lines 2, 3, and 4. **Total 2019 tuition and education amounts** = **▶** + 5

Add lines 1 and 5. **Total available tuition and education amounts** = 6

Enter the amount from line 26000 of your return if it is **\$31,984 or less**. If the amount is **more than \$31,984**, complete Part B of your Form PE428 before entering the result of the following calculation: amount from line 47 of your Form PE428 divided by 9.8%. 7

Total of lines 9 to 20 of your Form PE428 - 8

Line 7 minus line 8 (if negative, enter "0") = 9

### Unused Prince Edward Island tuition and education amounts claimed for 2019

Enter **whichever is less**: amount from line 1 or line 9 - **▶** 10

Line 9 minus line 10 = 11

### 2019 tuition and education amounts claimed for 2019

Enter **whichever is less**: amount from line 5 or line 11 + 12

Add lines 10 and 12. **Prince Edward Island tuition and education amounts claimed by the student for 2019** = 13

Enter this amount on line 58560 of your Form PE428. Continue on the next page to **transfer** or **carry forward** an unused amount.

**Transfer or carryforward of unused amount**

Complete this section if you are transferring a current-year amount or if you have an unused amount to carry forward to a future year.

To transfer all or part of the amount on line 19 to your spouse or common-law partner, to their parent or grandparent, or to your parent or grandparent, use Form T2202, TL11A, or TL11C to **designate** the individual and **specify** the provincial amount you are transferring. Enter the amount on line 20 below.

**Note:** You **cannot** transfer your unused current-year amounts to your parent or grandparent, or your spouse's or common-law partner's parent or grandparent, if your spouse or common-law partner is claiming an amount on line 58120 or line 58640 of their Form PE428.
