**Nova Scotia tuition and education amounts claimed for 2019**

Enter your unused Nova Scotia tuition and education amounts from your 2018 notice of assessment or reassessment. (If you resided in another province or territory on December 31, 2018, enter your unused federal tuition, education, and textbook amounts from your 2018 notice of assessment or reassessment.)

Enter the number of months from box 25 of Form T2202 and column C of Forms TL11A and TL11C.  $\times \$200 = 59180 +$  4

Add lines 2, 3, and 4. **Total 2019 tuition and education amounts** = 5

Add lines 1 and 5. **Total available tuition and education amounts** = 6

Enter the amount from line 26000 of your return if it is **\$29,590 or less**.  
If the amount is **more than \$29,590**, complete Part B of your Form NS428 before entering the result of the following calculation:  
amount from line 40 of your Form NS428 divided by 8.79%.
