

Complete this form to calculate your British Columbia training tax credit. You can claim this credit if you were a resident of British Columbia on December 31, 2021, and you completed an **eligible program** administered through the British Columbia Industry Training Authority or you passed a challenge exam and received a Certificate of Qualification from the British Columbia Industry Training Authority in the tax year.

There are four parts to the training tax credit:

- Certification tax credit for an eligible recognized program (non-Red Seal) or an eligible training program (Red Seal and non-Red Seal) (read Part 1 and Part 2 below)
- Enhanced tax credit for First Nations individuals and persons with disabilities (read Part 3 on the next page)

### Part 1 – Basic and certification tax credits (level 1 or 2 of a non-Red Seal program only)

You can claim these credits if, in 2021, you completed the level 1 or level 2 requirements for a non-Red Seal program or you passed a challenge exam and received a Certificate of Qualification for a program where graduating from the program qualifies for level 1 or level 2. You cannot claim these credits for a Red Seal program.
