

## Contributions to a Registered Party or to a Registered Association Information Return

This return must be completed by each registered agent or terminated registered agent of a registered association, electoral district agent, or terminated electoral district agent of a registered political party. In the event of death of a registered agent or electoral district agent, the return must be completed by the party's chief agent or by the association's financial agent, respectively. For help completing this return, see the **Income Tax Information Circular 75-2R9**.

Mail the completed return and any attachments to: **Charities Directorate, Canada Revenue Agency, Ottawa ON K1A 0L5**. The return must be filed on or before:

- June 30 of the year following the period covered by the return, in the case of a registered party; or
- May 31 of the year following the period covered by the return, in the case of a registered association.

If you are the registered agent or the electoral district agent, you must keep a copy of each receipt that you signed for income tax purposes. The receipts are for monetary contributions to the registered party or registered association during the period covered by this return. You must keep the receipts for two years after the end of the last calendar year in which the donations were made, and you must make them available to the Canada Revenue Agency during that time.
