

Fill out this worksheet if you want to calculate partial claims for the following amounts on your Form TD1YT, 2021 Yukon Personal Tax Credits Return.

Do not give your filled out worksheet to your employer or payer. Keep it for your records.

### Line 1 of Form TD1YT – Basic personal amount

If your estimated net income will be more than \$151,978, calculate your partial claim as follows:

\$64,533 minus line 4 (if zero or negative, enter \$12,421 at line 9)	=		5	
Divide line 5 by \$64,533	=		6

Enter this amount on Line 1 of Form TD1YT.	=			9

### Line 3 of Form TD1YT – Age amount

If you will be 65 or older on December 31, 2021, and your estimated net income from all sources will be between \$38,893 and \$90,313, calculate your partial claim as follows:

Your estimated net income for the year			2	
Base amount	-		3	
Line 2 minus line 3 (if negative, enter "0")	=		4	
Applicable rate		x	5	
Multiply line 4 by line 5.	=		6	
Line 1 minus line 6			-	
Enter this amount on line 3 of Form TD1YT.	=			7

### Line 9 of Form TD1YT – Yukon caregiver amount for eligible dependant or spouse or common-law partner

If the estimated net income of your infirm eligible dependant (aged 18 or older) or your infirm spouse or common-law partner, whichever applies, will be \$24,604 or less for the year, calculate your claim as follows:

Base amount				1
Your infirm dependant's estimated net income for the year	-		2	
Line 1 minus line 2 (maximum \$7,348)	=		3	
Enter the amount you claimed on line 7 or line 8, whichever applies, of Form TD1YT for this dependant	-		4	
Line 3 minus line 4				
Enter this amount on line 9 of Form TD1YT (if negative, enter "0")	=			5

### Line 10 of Form TD1YT – Yukon caregiver amount for dependant(s) age 18 or older

If the estimated net income of your infirm dependant (see notes below) will be between \$17,256 and \$24,604 for the year, calculate your partial claim as follows:

Base amount				1
Your infirm dependant's estimated net income for the year	-		2	
Line 1 minus line 2 (maximum \$7,348)	=		3	
Enter the amount, if any, that will be claimed by the dependant's <b>other</b> caregiver	-		4	
Line 3 minus line 4				
Enter this amount on line 10 of Form TD1YT (if negative, enter "0")	=			5

**Notes:** If you would like to claim this amount for more than one dependant, fill out a separate worksheet for each one.

Add all of the amounts from line 5 of each worksheet and enter the total amount on line 10 of Form TD1YT.

If you are claiming the Yukon caregiver amount for spouse or common-law partner or for an eligible dependant, see line 9 above.
