CCH Axcess Portal is a secure electronic storage space that provides bi-directional file exchange capabilities that make it easy for you to securely deliver and receive client documents, facilitating collaboration and supporting the upload of even the largest files.

With CCH Axcess Portal, your clients will experience unmatched convenience through instant access to their documents — including tax returns, financial statements and source documents. Meanwhile, your firm will benefit from reduced overhead and greater efficiency. CCH Axcess Portal provides more than just simple file exchange. In addition to giving clients and staff access to vital documents immediately from any location, CCH Axcess Portal helps you and your clients:

- Designate files as Read-Only or Read/Write for easier access and greater security.
- Check out documents to prevent other users from editing while they are being updated.

- Search, filter and display documents by file type, title, creator, keyword and more.
- Upload and download via the new Simplified User Interface — a new option for users who only want a simplified access method, compared to the standard, full-featured user interface.
- Extend access rights and security with Folder Level Security.

Expand Communication

With CCH Axcess Portal, you can share PDF files, web pages, hyperlinks, Microsoft[®] Excel[®] spreadsheets, Microsoft[®] Visio[®] diagrams, Microsoft[®] Word documents, Microsoft[®] PowerPoint[®] presentations and financial software data files, among others. For example, your clients can now upload their Intuit[®] QuickBooks[®] files to the CCH Axcess Portal, eliminating the need to exchange DVDs.

- Tax returns With CCH Axcess Portal, a single mouse click makes an entire tax return available for the client's review. After reviewing the return, your client simply signs the e-filing release and faxes it to you. The return is now ready for electronic filing.
- Financial records Clients often need the prior two years' tax returns to secure bank loans or for legal purposes. Simply publish the tax returns and source documents to CCH Axcess Portal, and your client can securely access them at any time.

Integration

CCH Axcess Portal tightly integrates with the other modules of CCH Axcess, including CCH Axcess^m Tax, CCH Axcess^m Document and CCH Axcess^m Practice. It also integrates with CCH^{\circ} ProSystem *fx*^{\circ} Engagement and CCH^{\circ} ProSystem *fx*^{\circ} Document.

- CCH Axcess Tax Use CCH Axcess Portal to collect source files. You can print organizers from CCH Axcess Tax to CCH Axcess Portal to save time and postage. Then print the completed return to CCH Axcess Portal so clients can access it throughout the year and in the future.
- CCH Axcess Practice Publish invoices to CCH Axcess Portal for faster billing, and capitalize on email notification features that remind clients to check the portal for new files.
- CCH ProSystem fx Engagement Publish workpapers to CCH Axcess Portal and import client-provided files directly using the Insert Workpaper Wizard. This bi-directional integration is a best-in-process approach that will save your firm time.

Open Integration Platform

Security — How Your Clients' Files Stay Private

CCH Axcess Portal was designed from the ground up to take optimal advantage of an online environment while ensuring the privacy of your clients' files. Because CCH Axcess Portal resides on Wolters Kluwer servers in our secure Class 4 data center, you can be confident that your data is secure. CCH Axcess Portal provides:

- Password-protected access CCH Axcess Portal utilizes 256-bit, Secure Socket Layer (SSL) encryption with password protected access. Since documents are hosted at the Business Logic Layer, users can only log in with a unique username and password.
- Secure file encryption Files are encrypted immediately upon upload to CCH Axcess
 Portal and remain encrypted even when not being accessed. Files remain encrypted while being passed over the Internet.
- Automatic virus scan For added protection, files are automatically scanned for viruses before being stored. All files are maintained behind secure firewalls to protect against outside intruders.

Delivering an Optimal Solution

CCH Axcess Portal functionality is not limited to sharing files with clients — it can also be used to facilitate collaboration among firm staff and for external business transactions.

- Portals Portals deliver full capabilities required to service a firm's business and individual clients. Clients can add multiple client users to improve collaboration with employees, family members and third parties like lawyers and banks.
- Client areas These are designed for clients to have a secure portal area for their external business or investment activities. The Client Area is accessible only by client users and the external entity. Client portals can be made available to clients by the firm as a value-add service or to help differentiate the firm from the competition.
